# Investment review

## Dear Investor

Welcome to the PUTM Bothwell Euro Sovereign Fund annual report for the 12 months to 30 September 2023.

## Performance Review

Over the review period, the PUTM Bothwell Euro Sovereign Fund returned -4.82%. (Source: abrdn, Gross of AMC, GBP, based on the movement in the Cancellation Price for 12 months to 30/09/2023). This was compared with the return of -4.75% for its benchmark index.

# Investment review

## Portfolio and Market Review

Over the past 12 months, the Fund performed broadly in line with its benchmark. Yet there were significant short-term swings while investor sentiment was determined by inflation, central bank policy expectations and more recently worries over the health of the global economy.

During the fourth quarter of 2022, the Fund delivered a strong performance relative to its benchmark. Early in the period, in reaction to September's Gilt market turmoil, the Bank of England (BoE) widened the scope of daily Gilt-buying operations and Gilts recovered some lost ground in October and November, before weakening again in December. Amid the political chaos, the BoE lifted rates by 75 basis points (bps) in November and a further 50bps in December, taking the cash rate to 3.5%.

Many of the portfolio's structural positions for higher yields performed well over the fourth quarter, while tactical trading also produced positive returns. Curve positioning was the largest positive contributor to performance. UK curve positioning for higher longer-dated yields versus medium-dated yields had a strong quarter. European curve exposure was also a strong positive. Our received medium-term European government bonds versus 30-year German yields performed very well. Duration strategies boosted performance, where our short German Bund trade was the top performer. Relative value strategies added modestly. The NextGenerationEU (NGEU) versus Germany trade was a top performer. Meanwhile, our underweight French versus German 10-year futures position also boosted returns. On the other side of the ledger, our UK front-end long versus short 10-year government bond trade underperformed as 10-year rates were unable to keep up with the rise in front-rated yields.

In terms of activity over the fourth quarter, while the Fund traded duration from both short and long, it was primarily positioned for higher yields via shorts in 10-year German Bunds and curve steepener positions across the UK, Europe and the US. We added a long-dated steepening strategy in UK government bonds, selling 30-year yields versus 10-year yields. Elsewhere, medium-term rates in the eurozone looked extremely elevated versus 30-year German yields, so we added a relative value strategy, receiving five-year-five-year (5y/5y) European rates versus selling 30-year bonds. Tactical trading involved buying and selling liquid 10-year futures contracts in Bunds, Gilts and US Treasuries. Two additional strategies were added. A long 30-year NGEU versus Germany position was added. Additional steepening risk in the US was also added, buying two-year and five-year bonds and selling 10-year bonds. Relative value strategy additions included a Dutch butterfly trade (long belly versus wings) by buying 20-year bonds while selling 10-year and 30-year bonds. Heading into the end of the review period, the Fund reduced exposure to Australia by selling 10-year futures.

In the first quarter of 2023, the Fund modestly underperformed the benchmark. The period initially started on a positive note and bond markets were robust in January, supported by lower energy prices. However, falling unemployment and stickier inflation dominated February data, creating an ugly environment for bonds, and hawkish central bank rhetoric pushed the yield curve higher and flatter. This changed again in March as fears mounted about the banking system, whipsawing markets. Overall, yields ended the quarter lower.

Our longer-term strategies performed relatively well during the first quarter. However, the Fund made some duration trades that suffered under extreme market reversals. Tactical trading was negative, and awkward reversals in key markets caught the Fund offside. In many

cases, our stop-loss management worked against us as the market proceeded to move in our direction after the decision to stop out of strategy. Yet, we still believe that rigorous stop-loss management is key to long-term performance. Our position in UK duration suffered, particularly in February. US curve trading also proved difficult.

Unlucky moves in the curve damaged confidence in the Fund's key position in five-year/30-year steepeners. Relative value strategies in Europe made losses. Our NGEU versus Germany position suffered after being the top performer in the previous quarter.

In terms of activity in the first quarter, the Fund was primarily positioned for higher yields via shorts in 10-year German Bunds and curve steepener positions across the UK, Europe and the US. We increased the size of our European forward curve steepener in January. Having started the year long of duration, the Fund sold duration in January across EU and US government bonds. This took the Fund short duration into the middle of January. As yields continued to lurch lower, the Fund covered these shorts heading into and coming out of the January central bank meetings. A relatively dovish statement from US Federal Reserve (Fed) Chair Jerome Powell pushed yields lower, and the Fund stopped out of key short duration positions that had been added as hedges to longer-term trades. Elsewhere, the Fund added a flattening strategy in Australian futures, short three-year versus long 10-year. This flattening strategy generated a positive return and was unwound later in the quarter. The Fund added a received swaps position versus a short 10-year German bond position. The Fund ended the review period long of duration, primarily through Australian government bonds. We remained short of European duration via Bunds, with long exposure in UK short-dated government bonds

In the second quarter of 2023, the Fund underperformed the benchmark as higher core inflation and better economic data provided a hostile backdrop for government bonds. The UK was the standout underperformer, with 10-year Gilt yields increasing by around 90 bps in the three months to 30 June. While bonds were weak across the board, front-end rates came under even more pressure, leading to a sharp re-pricing in global bonds. The June BoE Monetary Policy Committee (MPC) meeting hiked rates by 50 bps after previous 25 bp moves. The European Central Bank (ECB) also lifted rates by 50 bps to 3.50%. Yet the Fed 'paused' at the June meeting.

Our duration position – particularly our front-end UK position – suffered in the second quarter as awkward reversals in key markets caught the Fund offside. US curve trading also proved difficult due to increasingly hawkish central bank rhetoric. European curve positioning and our NGEU holdings were the best-performing strategies. After the extraordinary flattening inversion that occurred last year, pressure eased on the curve, and forward yields started to re-normalise between 10-year and 30-year rates. Meanwhile, NGEU holdings continued to outperform German bonds on expectations of lower realised EU supply.

In terms of activity, the Fund started the second quarter long of duration, primarily through Australian government bonds. It remained short of European duration via Bunds, with long exposure in UK front-end government bonds. Early on, the Fund increased steepening exposure to US curves. Duration was maintained at the same level throughout the quarter. Trading activity mainly consisted of tactical additions and small reductions to headline duration, typically keeping duration around 0.35-year long. Towards the end of the period, the Fund stopped out of its received front-end UK rates strategy, representing a painful cut on the back of accelerating inflation data and higher-than-expected wage measures in the UK. The Fund ended the period long duration via Australia, with

duration exposure neutral across Europe, the UK and the US. We continued to hold steepening exposure across Europe, via long-dated forwards, in addition to US five-year versus 10-year bonds.

Finally, the performance of the Fund was positive over the third quarter when policy tightening by central banks began to have more of an impact on economic growth. Several Purchasing Managers' Index data from the US, UK, eurozone and Germany showed considerable slowdowns. While August was a quiet month for central bank meetings, the BoE hiked interest rates by 25 bps. Overall, there was a global move higher in yields.

During the third quarter, positive contributors included US and Germany yield curve steepeners due to the 'higher for longer' message by central banks. Elsewhere, the long Australian 10-year versus US 10-year as well as Canadian 10-year versus US 10-year positions also contributed to performance. In contrast, the receive Australian 5y/5y position suffered as yields moved higher in sympathy with the US-led global duration sell-off. Meanwhile, the long German 10-year position also suffered.

In terms of activity in the third quarter of 2023, the Fund started and ended the period long duration, which was traded tactically in small sizes with the Fund trading in a range of around 0.3-year to 0.4-year long for most of the period. The core long position was switched from Australia to Germany given the deterioration in the growth outlook for the eurozone. In addition, the Fund closed/took profit on the EU 30-year versus German 30-year spread position. It reduced duration in July via closing the received Australian 5y/5y position following stronger Australian employment data. The Fund added a tactical long Canadian 10-year versus US 10-year position on the belief that Canada would recover some of the sharp underperformance in July. Elsewhere, the Fund closed the position post spread widening after US non-farm payrolls data. As we approach the end of central bank hiking cycles, the Fund increased yield curve steepening exposure in July through adding to an existing US curve position and adding a new position in Germany. Curves re-steepened aggressively over the quarter and while we continue to like the steepening theme as a structural view, we felt it was prudent to reduce risk and take profits at the end of the quarter. The US curve position was closed completely while the Germany position was reduced in size. The Fund also closed a long-held euro forward curve steeper position as part of a portfolio simplification exercise. In anticipation of a significant increase in the volume of European bond supply (concentrated in semi-core markets) coming to the market during the first week of September, the Fund sold duration tactically via French 10-year bonds as a partial offset against the core long German 10-year position. We closed/took profit on this spread position at the end of the quarter.

### Market Outlook and Fund Strategy

The US was very much at the front and centre of what was driving global bond markets by the end of the period, with data continuing to prove more resilient than the market had expected while the US Treasury's August refunding announcement added to the supply/demand imbalance as investors grew increasingly concerned about the US fiscal outlook. These factors, along with the consistent 'higher for longer' message delivered by a number of central banks including the Federal Reserve, contributed to long end yields repricing aggressively higher and caused global yield curves to bear steepen. We continue to like the steepening theme as a strategic view and hold curve steepeners in Germany. The ECB has likely reached the end of its hiking cycle and with risks to the growth outlook for the eurozone skewed to the downside, there is scope for curves to bull steepen as the lagged effect of policy tightening takes

hold and the market focus moves away from the possibility of further hikes to rate cuts. In addition, discussions are underway at the ECB over the potential timing of further quantitative tightening (QT), which comes at a time when there is already a global supply/demand imbalance in the market. The volume of net government bond issuance is also set to remain at an extremely elevated level next year. These factors should also be supportive of a steeper curve over a six to 12 months.

The Fund has a modest long duration position in Germany at the five-year point of the curve having recently shifted our exposure from the 10-year point as we were of the view that the five-year point should be more protected should the recent sell-off persist. We expect the eurozone economy to continue to weaken as we move towards 2024; however, we prefer to hold a small long duration position with a view to increasing when the global backdrop (particularly in the US) becomes more supportive for bonds.

# Statistical information

## Investment objective

The Fund aims to provide a total return (a combination of capital growth and income) by outperforming the benchmark (before fees) by 0.3% to 0.8% per annum over any given 3 year period.

The benchmark is the JPM Euro Gov Bond AAA All Mats Index (the "Index").

## Investment policy

The Fund aims to achieve its objective by investing over 70% in fixed, floating rate index linked securities issued by supranational bodies and government bodies across all maturities that are denominated in Euros. The Fund will invest in a broad range interest bearing securities selected from issues denominated in Euros and with the ability to have some exposure to other currencies.

The Fund may also invest in other transferable securities, units in collective investment schemes and may hold up to 20% of its assets in money market instruments, deposits, cash and near cash. The Fund may, at the Investment Adviser's discretion, hold in excess of 20% of its assets in money market instruments, deposits, cash near cash on a temporary basis in exceptional market circumstances, if deemed to be in the best interests of Unitholders.

Derivatives may be used for efficient portfolio management and hedging only.

## Investment strategy

Although at least 70% of the Fund is invested in components of the Index, the Fund is actively managed.

The Investment Adviser uses a stock selection model to select individual holdings, where they believe there is misalignment in the assessment of growth prospects and creditworthiness of the holdings and that of the market, while giving consideration of future economic and business conditions. The Fund is managed within constraints, so that divergence from the Index is controlled.

The Fund's portfolio may, therefore, be similar to the components of the Index.

## Revenue distribution and pricing

Units of the Fund are available as Class 'B' accumulation units (where revenue is reinvested to enhance the unit price). There will be two potential distributions in each accounting year: an interim distribution as at 31 March and a final distribution as at 30 September.

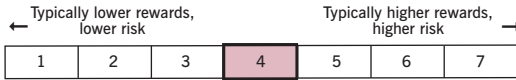
At each distribution the net revenue after deduction of expenses, arising in the preceding six months from the investments of the Fund, is apportioned amongst the unitholders. Unitholders receive a tax voucher giving details of the distribution and the Manager's Report no later than two months after these dates.

## Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. # Notes to the financial statements

## Note 1 Accounting policies

### (a) Basis of preparation

The financial statements have been prepared under the historical cost basis, as modified by the revaluation of investments and in compliance with Financial Reporting Standard (FRS 102) and in accordance with the Statement of Recommended Practice ('SORP') for Financial Statements of UK Authorised Funds issued by The Investment Association ('IA') in May 2014, and as amended in June 2017.

These financial statements are prepared on a going concern basis. The Manager has made an assessment of the Fund's ability to continue as a going concern, and is satisfied it has the resources to continue in business for the foreseeable future and is not aware of any material uncertainties that may cast significant doubt on this assessment. This assessment is made for a period of 12 months from when the financial statements are authorised for issue and considers liquidity, declines in global capital markets, known redemption levels, expense projections and key service provider's operational resilience.

### (b) Valuation of investments

The quoted investments of the Fund have been valued at bid dealing prices as at close of business on 29 September 2023, the last valuation point in the accounting year, in accordance with the Trust Deed.

Investments in collective investment schemes have been valued at bid price for dual priced funds or the single price for single priced funds. Where these investments are managed by the Manager or an associate of the Manager, the holdings have been valued at the cancellation price for dual priced funds or the single price for single priced funds. This price is the last available published price at the year end.

Derivatives are valued as at close of business on 29 September 2023, the last valuation point of the accounting year.

Exchange traded derivatives are priced at fair value, which is deemed to be the bid price.

Over-the-counter derivatives are priced at fair value using valuation models or data sourced from market data providers.

### (c) Foreign exchange

Transactions in foreign currencies during the year are translated into Sterling (the functional currency of the Fund), at the rates of exchange ruling on the transaction date. Amounts held in foreign currencies have been translated at the rate of exchange ruling at close of business, 29 September 2023, the last valuation point in the accounting year.

### (d) Revenue

Interest receivable on bank deposits is accounted for on a receipts basis and money market funds is accounted for on an accruals basis. Interest receivable from debt securities is accounted for on an effective interest rate basis.

Accrued interest purchased or sold is excluded from the cost of the security and is accounted for as revenue.

Any commission arising from stocklending is recognised on an accruals basis and is disclosed net of fees.

Interest received from or paid to the Fund from over-the-counter derivatives designed to protect income is treated as revenue. Interest received from or paid to the Fund from over-the-counter derivatives designed to protect capital is treated as capital.

# Notes to the financial statements

## Note 1 Accounting policies (continued)

### (e) Expenses

Expenses are accounted for on an accruals basis. Expenses of the Fund are charged against revenue, except for the safe custody charge and costs associated with the purchase and sale of investments, which are charged to capital.

### (f) Taxation

The Fund satisfied the rules of SI 2006/964, Reg 19 throughout the period. All distributions made are therefore made as interest distributions. The Fund has no corporate tax liability as interest distributions are tax deductible.

### (g) Deferred taxation

Deferred tax is provided at current rates of corporation tax on all timing differences which have originated but not reversed by the Balance sheet date. Deferred tax is not recognised on permanent differences. Deferred tax assets are recognised only to the extent that the Manager considers it is more likely than not that there will be taxable profits from which underlying timing differences can be deducted.

## Note 2 Distribution policies

### (a) Basis of distribution

Revenue produced by the Fund's investments accumulates during each accounting period. If, at the end of each accounting period, revenue exceeds expenses, the net revenue of the Fund is available to be distributed/accumulated to unitholders.

The Fund is more than 60% invested in qualifying investments (as defined by SI 2006/964, Reg 20) and will pay an interest distribution.

### (b) Unclaimed distributions

Distributions remaining unclaimed after six years are paid into the Fund as part of the capital property.

### (c) Interest from debt securities

Future cash flows on all assets are considered when calculating revenue on an effective interest rate basis and where, in the Manager's view there is doubt as to the final maturity value, an estimate of the final redemption proceeds will be made in determining those cash flows. The impact of this will be to reduce the revenue from debt securities, and therefore the revenue distributed, whilst preserving capital within the Fund.

### (d) Expenses

In determining the net revenue available for distribution, charges in relation to the safe custody, of investments are ultimately borne by capital.

## Note 3 Risk management policies

The risks arising from the Fund's financial instruments are market price risk, interest rate risk, foreign currency risk, liquidity risk, credit risk and counterparty risk. The Manager's policies for managing these risks are summarised below and have been applied throughout the year.

### (a) Market price risk

Market price risk arises mainly from uncertainty about future prices of financial instruments held. It represents the potential loss the Fund might suffer through holding market positions in the face of price movements. The Fund's investment portfolio is exposed to market fluctuations which are monitored by the Manager in pursuit of the investment objectives and policies. Adherence to investment guidelines and to investment and borrowing powers set out in the Trust Deed, the Prospectus and in the Collective Investment Schemes Sourcebook ("the Sourcebook") mitigates the risk of excessive exposure to any particular type of security or issuer.

# Notes to the financial statements

## **Note 3 Risk management policies (continued)**

### **(b) Interest rate risk**

The Fund's assets are comprised of mainly fixed interest rate securities. There is therefore a risk that the capital value of investments will vary as a result of the market's sentiment regarding future interest rates.

Expectations of future rates may result in an increase or decrease in the value of investments held. In general, if interest rates rise the revenue potential of the Fund also rises but the value of fixed interest rate securities will decline. A decline in interest rates will in general have the opposite effect.

Any transactions in fixed interest securities must be used in accordance with the investment objective of the Fund and must be deemed by the Investment Manager to be economically appropriate. Regular production of portfolio risk reports highlight concentrations of risk, including interest rate risk, for this Fund.

Interest receivable on bank deposits or payable on bank overdraft positions will be affected by fluctuations in interest rates.

### **(c) Foreign currency risk**

All the Fund's investment portfolio is invested in overseas securities and the Balance sheet can be (significantly) affected by movements in foreign exchange rates. The Fund may be subject to short term exposure to exchange rate movements between placing the purchase or sale of securities and agreeing a related currency transaction albeit usually the two transactions are agreed at the same time.

Any such currency transactions must be used in accordance with the investment objective of the Fund and must be deemed by the Investment Manager to be economically appropriate. Regular production of portfolio risk reports highlight concentrations of risk, including currency risk, for the Fund.

### **(d) Liquidity risk**

The Fund's assets are comprised of mainly readily realisable securities. If insufficient cash is available to finance unitholder redemptions then securities held by the Fund may need to be sold. The risk of low market liquidity, through reduced trading volumes, may affect the ability of the Fund to trade financial instruments at values previously indicated by financial brokers. From time to time, liquidity may also be affected by stock specific or economic events. To manage these risks the Manager performs market research in order to achieve the best price for any transactions entered into on behalf of the Fund. All stocks are valued daily but those stocks identified as being less liquid are reviewed on a regular basis for pricing accuracy.

### **(e) Credit risk**

At the Balance sheet date some 96.57% (30/09/22: 98.20%) of the Fund's assets were held in government bonds.

Supranational and government bonds involve the risk that the bond issuer will be unable to meet its liability to pay interest or redeem the bond. The Fund Manager selects bonds taking into account the credit rating, bearing in mind the Fund's objective.

### **(f) Counterparty risk**

Certain transactions in securities that the Fund enters into expose it to the risk that the counterparty will not deliver the investment (purchase) or cash (sale) after the Fund has fulfilled its responsibilities. The Fund only buys and sells investments through brokers which have been approved by the Manager as an acceptable counterparty. This list is reviewed annually.

## Note 3 Risk management policies (continued)

### (g) Derivatives

Derivative transactions may be used by the Fund for the purposes of meeting its investment objectives and also for hedging. In doing so the Manager may make use of a variety of derivative instruments in accordance with the Sourcebook. The use of derivatives for investment purposes means that the net asset value of the Fund may at times have high volatility, although derivatives will not be used with the intention of raising the risk profile of the Fund. Where derivatives are used for hedging this will not compromise the risk profile of the Fund. Use of derivatives will not knowingly contravene any relevant investment objective or limits.

The Manager has used exchange traded futures to hedge the value of those assets denominated in foreign currency.

Interest rate swaps have been used to hedge the interest rate risk of holding fixed rate bonds during the period.

The derivative counterparties are shown at the bottom of the Portfolio of investments on page 6.

### Sensitivity analysis

#### Interest rate risk sensitivity

Changes in interest rates or changes in expectation of future interest rates may result in an increase or decrease in the the market value of the investments held. A one percent increase in interest rates (based on current parameters used by the Manager's Investment Risk department) would have the effect of decreasing the return and net assets by £1,958,337 (30/09/22: £2,816,079). A one percent decrease would have an equal and opposite effect.

#### Foreign currency risk sensitivity

A five percent increase in the value of the Fund's foreign currency exposure would have the effect of increasing the return and net assets by £1,359,858 (30/09/22: £1,922,846). A five percent decrease would have an equal and opposite effect.

### Assessment of Value

We are required to perform an annual assessment of the value for money for each unit class of PUTM Bothwell Bothwell Euro Sovereign Fund. This has been performed based on the information available as at 30 September 2023.

We have performed this review having regard to a wide range of factors. In doing so, we have made comparison with the other unit classes of the relevant fund, with the unit classes and sub-funds within our fund ranges and also with comparable unit classes and sub-funds in the rest of the market.

Broadly speaking, assessment of value requires consideration of a combination of factors, including the return achieved, the price paid, the risk taken and the quality and range of services provided by the asset manager. This also needs to be considered in the context of the investment objectives and policy for the Fund, the target investor and the recommended holding period.

In considering cost, regard needs to be had to the total cost of investing, including any adviser charges, platform charges, adviser fees and the on-going annual management charge. Regard also needs to be had to the degree of active management; as an investor, you would not be receiving value, if you were being charged fees for active portfolio management, where in fact, the Fund's composition of performance is staying very close to a benchmark. These factors also need to be considered in the context of the size of the portfolio and the ability of larger funds to benefit from economies of scale. As regards performance, it is important that performance is considered over an appropriate timescale given the Fund's objectives, and should be measured net of fees.

Based on our assessment of the value, PUTM are generally comfortable that the Fund meets most of the required Assessment of Value criteria. However, the Fund is not meeting its target outperformance of the benchmark index, which PUTM are reviewing and may take action to rectify the underperformance.
